The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND ADDRESS

The name of the limited liability company shall be 2216 OCALA, LLC ("Company"). The principal place of business of the Company in Florida shall be 4497 NW 78th Avenue, Ocala, FL 34482.

ARTICLE II
DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization or the laws of the State of Florida.

ARTICLE III
PURPOSES AND POWERS

The Company shall be managed by a Manager, Managers and other named Officers in accordance with regulations adopted by the Member for the management of the

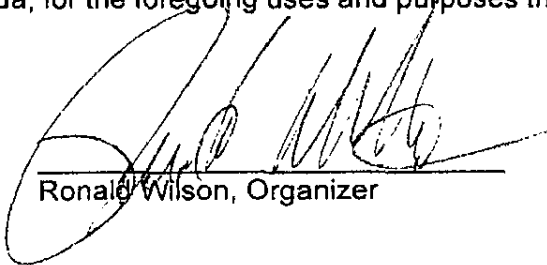

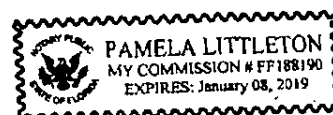

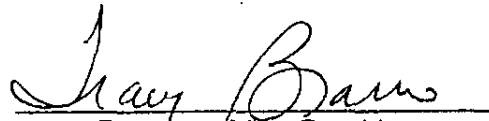
