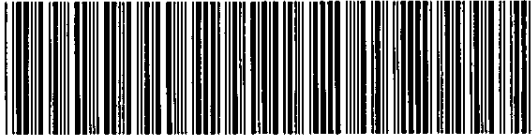

2. Article I of the Articles of Organization is deleted in its entirety and the following is adopted by the limited liability company and substituted in lieu thereof:

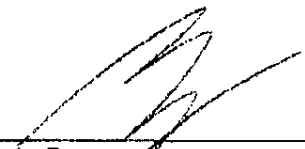
ARTICLE I - NAME
