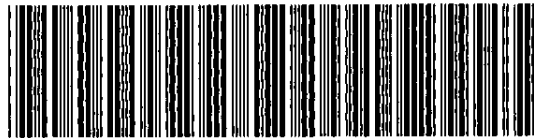

ARTICLE 1 - NAME

The name of the limited liability company shall be **MERCHANDISING MANAGEMENT SERVICES, LLC** ("Company").

ARTICLE 2 - ADDRESS




