

# April 2015 ARTICLES of ORGANIZATION OroFino Catering, LLC

AGREEMENT made on this 16 day of April, 2015 among the members: Michael A Orofino (Auburn, NY), LuAnne Kanter (Windermere, FL) Melina Carnicelli (Auburn, NY), Matthew Carnicelli (Auburn, NY) for the purpose of food service catering for clients in locations of clients' choice.

In consideration of planning and implementing catering services, the members agree to:

- 1. An equal partnership regarding roles, responsibilities, expenses and income
- Distribute catering event profit equally among partners at close of event and after all
  expenses are paid and after 20% of profit is designated savings to business account.
  Should event run a deficit, the deficit will be covered in equal share (25%) among the
  partners.
- 3. Effectively fulfill individual responsibilities, in a timely manner, as agreed upon by members (see below)
- 4. Periodic updates, as agreed upon, regarding individual areas of responsibilities and financial status
- 5. Seek agreement from all members prior to:
  - a. confirming an event
  - b. setting an event date
  - c. setting menu & event quote
  - d. incurring an expense over \$25 for any purchase, not including event cost of goods
- 6. Prior to confirming a catering job, each individual member will state her/his availability to work the event. If any member is not available to be present at a confirmed event but participates in pre-event planning/prep, he/she will share profit as usual less his/her share of gratuity which will be shared equally between/among those members working the event. If any member is unavailable for a confirmed event in any capacity, her/his share of profit and gratuity will be divided equally between/among those members who are available.
- 7. Major areas of responsibility:
  - a. Mike Orofino menu design & pricing; equipment; chef
  - b. LuAnne Kanter accounting; event décor; pastry chef
  - c. Melina Carnicelli -accounting; internal/external communications; hors d'oeurves
  - d. Matthew Carnicelli transportation; event venue set-up & clean-up; chef

All other duties/tasks necessary for each event, decided upon by members.

## 8. Accounting Procedures:

- a. Price quotes for event catering services sent to clients in a timely manner. complimentary client discounts, as agreed upon among members;
- b. 25% deposits required from clients (along with signed Agreement) to confirm service;
- c. Client balance due 1-2weeks prior to event; payable to OroFino Catering, LLC;
- d. Cancellation Policy in effect for all confirmed events (see Agreement doc);
- e. 8% sales tax levied on each quote, including service gratuity;
- f. Profit is amount of sales less expenses and 8% sales tax;
- g. 20% of each event profit to remain in business account for operations and supplies;
- 80% of profit from each event divided equally among members, or as decided among members, within one (1) week of event date. If event runs a deficit, expenses covered as agreed upon by members;
- i. Expense receipts for each event kept on file for three (3) years;
- j. Monthly income/expense accounting to all members;
- k. Business year: January 1-December 31;
- All payments for goods/services made on behalf of OroFino Catering, LLC via business checking account;
- m. Catering AGREEMENTS are between CLIENT and OroFino CATERING, LLC.
