ARTICLE II - PRINCIPAL OFFICE


The mailing address and street address of the principal office of the Company is 801 Via Lombardy, Winter Park, Florida 32789.

ARTICLE IV - MANAGEMENT


The Company is a manager-managed limited liability company and the initial manager of the Company is RJBC CCRLD Technology X, LLC, a Florida limited liability company.
