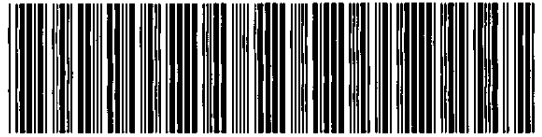

ARTICLE III - Management




