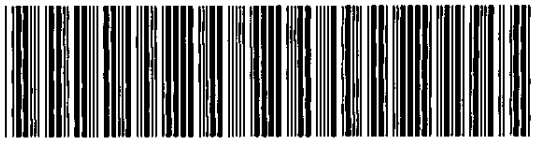

ARTICLE III- Management




