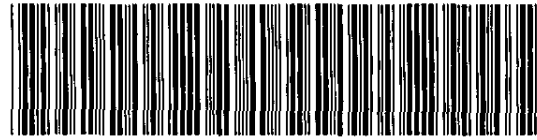

**ARTICLE IV - MANAGEMENT.**


