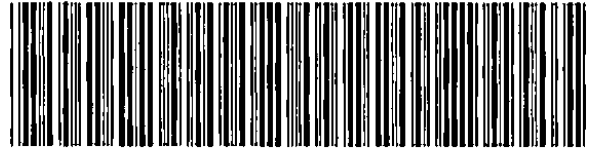

Article I of the Articles of Organization of this Company is amended to read as follows:


