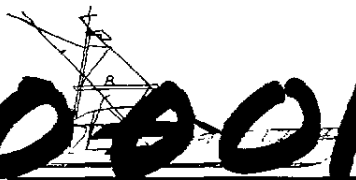

I am the sole owner and president of the business entity Rickenbacker Marina, Inc., an S Corporation, document number M27151.

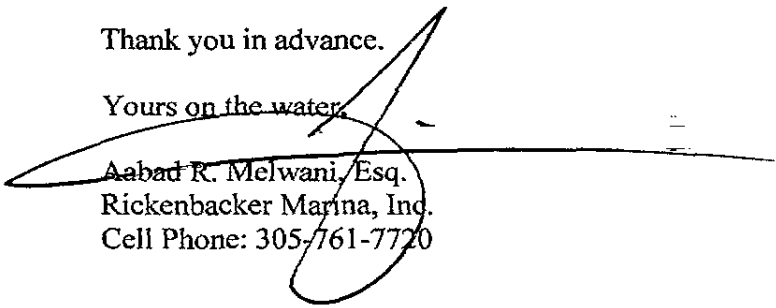
I have made a filing submission for Rickenbacker Marina, LLC.
