**ARTICLES OF ORGANIZATION
OF
DMFH LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is DMFH LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address of the Company is 2665 South Bayshore Drive, Suite 1020, Coconut Grove, Florida 33133-5463.

ARTICLE III. REGISTERED AGENT AND OFFICE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.

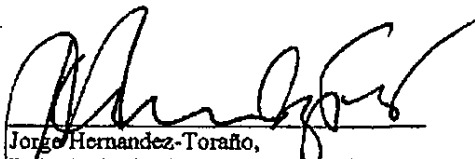
ARTICLE VII. ADDITIONAL MEMBERS

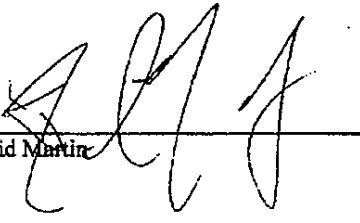
