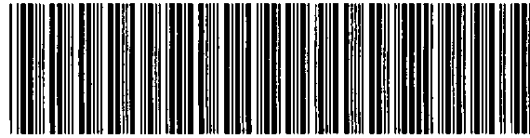


ARTICLE VI - Amendment:
