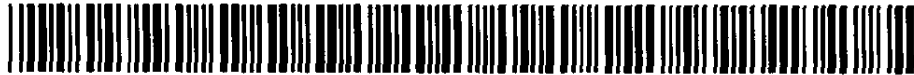

**ARTICLES OF ORGANIZATION


