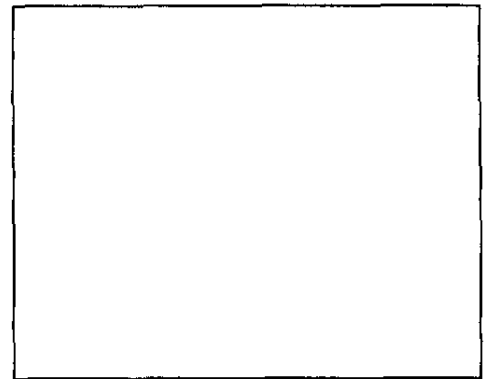

ARTICLE I
NAME

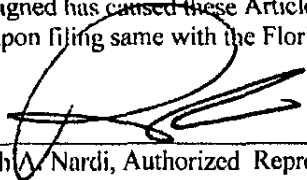

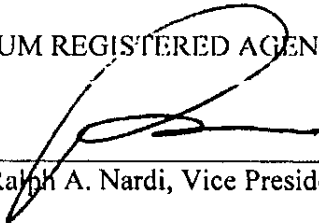
