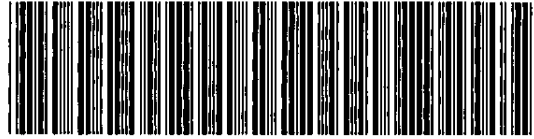



1. **Name.** The name of the limited liability company is HMG BROKERAGE, LLC
