#### ARTICLE IV - Management:

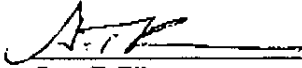

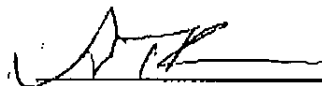
