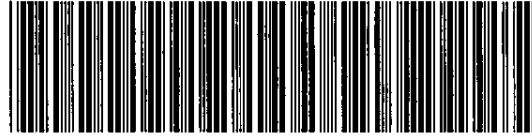

1. **Name.** The name of the limited liability company is PIK, LLC


4. **Term.** The term of this LLC shall be perpetual.


