

## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

DREAM KITCHENS AND BATH, LLC (hereafter to be known as Dream Kitchen and Bath, LLC)

- 1. Name and Document Number. The name of the Company immediately prior to the filing of this Amendment is Dream Kitchens and Bath, LLC, and its document number on file with the Division of Corporations of the Florida Department of State is L16000080274.
- 2. <u>Amendment to Article I</u>. Article I of the Articles of Organization shall be deleted in its entirety and the following shall be added in its place:

## "ARTICLE I - NAME:

The name of the limited liability company is Dream Kitchen and Bath, LLC (the "Company")."

- 3. <u>Effective Date of Amendment</u>. This Amendment was adopted and shall be effective on the date this Amendment is filed with the Division of Corporations of the Florida Department of State.
- 4. <u>Effect of Amendment</u>. The Articles of Organization shall remain in full force and effect except as expressly modified by this Amendment.
