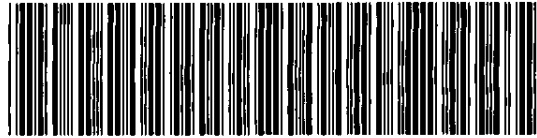

NAME. The name of the limited liability company is Champion by Mileva, LLC.


ARTICLE II.

ARTICLE VI.


MANAGEMENT. The limited liability company will be managed by its members.
