AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
THE OASIS AT HIGHWOODS PRESERVE, LLC

The undersigned hereby submits these Amended and Restated Articles of Organization (the "*Articles of Organization*") for The Oasis at Highwoods Preserve, LLC (the "*Company*"), under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

These Articles of Organization amend and restate in the entirety the articles of organization originally filed by the Company on June 15, 2016 (the "*Original Articles*").

ARTICLE I - Name

The name of the liability company as originally filed under the Original Articles was The Oasis at Highwood's Preserve, LLC (the word "Highwood's" initially with an apostrophe).

The name of the limited liability company is The Oasis at Highwoods Preserve, LLC (the "*Company*").

ARTICLE II - Address

The mailing and street address of the principal office of the Company is 247 North Westmonte Drive, Altamonte Springs, Florida 32714.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of a written operating agreement of the Company, as the same may be amended from time to time (the "*Operating Agreement*").

ARTICLE IV - Management

The Company shall be manager-managed, elected as described in the Operating Agreement. The initial manager of the Company shall be The Oasis at Highwoods Preserve GP, LLC, 247 North Westmonte Drive, Altamonte Springs, Florida 32714.

ARTICLE V - Admission of Additional Members

The Company shall admit new members only upon the unanimous written consent of all the then-existing member(s) of the Company.

**ARTICLE VII - Registered Agent and Office**

The name and Florida street address of the initial registered agent of the Company is NRAI Services, Inc., at 1200 South Pine Island Road, Plantation, FL 33324.


**ARTICLE VIII - Amendments**
