AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF THE OASIS AT HIGHWOODS PRESERVE, LLC

The undersigned hereby submits these Amended and Restated Articles of Organization (these "A/R Articles of Organization") for The Oasis at Highwoods Preserve, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.
