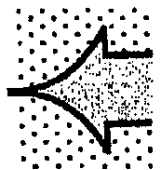
Dear Mr. Linqanti:

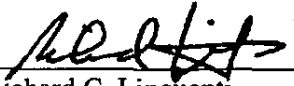
