## ARTICLES OF ORGANIZATION OF 2766 Park St, LLC

The undersigned, who intends to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, does hereby state and certify the following:

- 1. Name. The name of the Limited Liability Company shall be 2766 Park St, LLC
- 2. <u>Duration of Company</u>. The company shall have perpetual duration.
