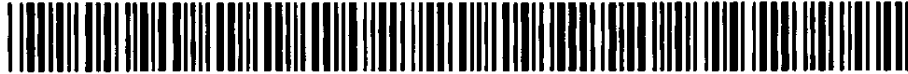

**ARTICLES OF ORGANIZATION

Operating Agreement


