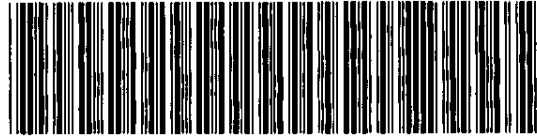

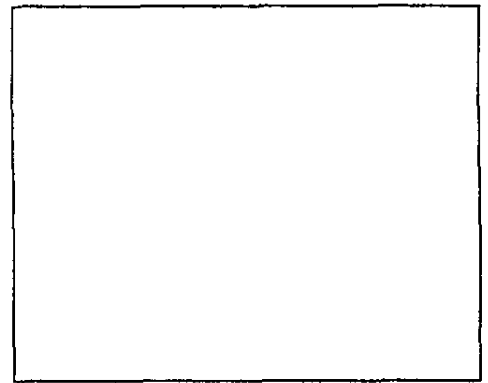

NAME


