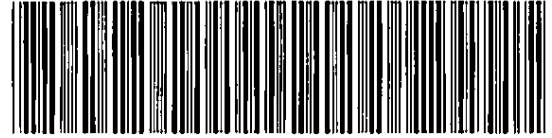



SECOND: Article I of the Company's Articles of Organization is hereby amended in its entirety to read as follows:


"ARTICLE I
