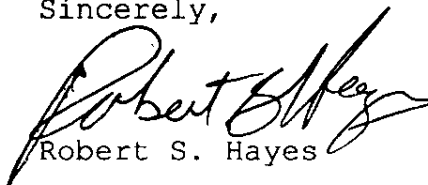

**ARTICLE I. COMPANY NAME**

The name of this Limited Liability Company is 1611 MINNESOTA AVENUE, LLC.
