ARTICLE 1 - NAME

The name of the limited liability company shall be **MIAMI ELA LIMITED LIABILITY COMPANY** ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 5 - PURPOSES AND POWERS

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.


