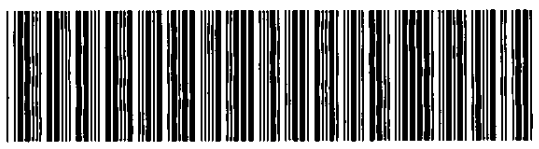

The Company is to be managed by managers, who shall serve as managers until replaced by the members.


ARTICLE VI


