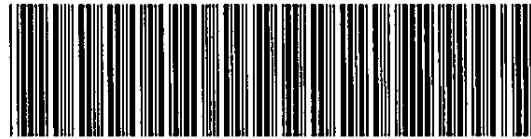

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
LEGACYSHIELD, LLC**

Pursuant to the Florida Revised Limited Liability Company Act (the "Act") and specifically Florida Statute §605.0202, LegacyShield, LLC (the "Company") whose Articles of Organization were first filed in Florida effective as of January 1, 2017, hereby submits these Amended and Restated Articles of Organization to replace entirely any previously filed Articles of Organization:

ARTICLE I: NAME

The name of the Company is LegacyShield, LLC, effective January 1, 2017. Prior to January 1, 2017, the Company was known as Insol Group, LLC.

ARTICLE II: ADDRESS
