The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 605 of the Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is AirTrace LLC (the "Company").

ARTICLE II

The mailing and street address of the principal place of business of the Company are 550 NW 29th Street, Miami, Florida 33127.

ARTICLE III

The name and street address of the initial registered agent of the Company are Elliot Klein, 550 NW 29th Street, Miami, Dade County, Florida 33127.

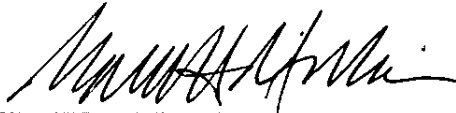
ARTICLE IV
