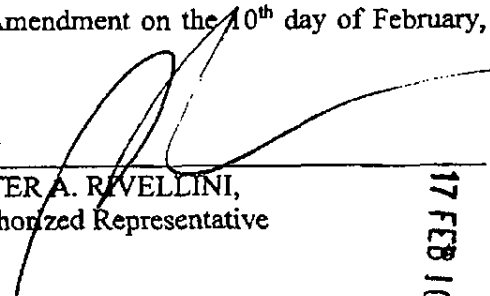
1. Name of Limited Liability Company: MoMo, LLC
