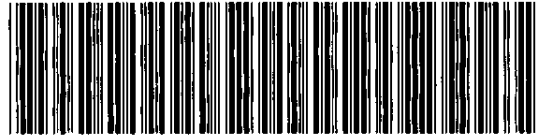

The name of the limited liability company is **JET AVIATION SPECIALISTS, LLC** (the "Company").


