**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
BASELOAD SECURITY LLC**

Pursuant to the Florida Revised Limited Liability Company Act (the "Act") and specifically Florida Statute § 605.0202, Baseload Security LLC (the "Company") whose Articles of Organization were first filed in Florida effective as of February 23, 2017 hereby submits these Amended and Restated Articles of Organization to replace entirely any previously filed Articles of Organization, effective as of January 28, 2019 ("Effective Date").

ARTICLE I: NAME

The name of the limited liability company is Baseload Security LLC (the "Company").

ARTICLE IV: DURATION AND EXISTENCE; EFFECTIVE DATE

The Company was formed on February 23, 2017, and will continue to exist perpetually.

ARTICLE V: MANAGEMENT

The Company shall be managed by a Board of Managers (the "Board") (which shall have duties, powers and authority similar to that of a Board of Directors) and shall operate through officers elected by the Board, all as provided in the operating agreement (the "Operating Agreement") of the members of the Company (the "Members"). Ownership interests in the Company by its Members may, but need not, be evidenced by certificates signed by the president or any vice-president of the Company and by the secretary or any assistant-secretary of the Company. Transfers of certificates are restricted by the terms of the Limited Liability Company Operating Agreement among the Members of the Company. The Members of the Company shall have the right to admit additional members pursuant to the terms and conditions contained in the Operating Agreement of the Company; any new member agrees to be bound by and to such Operating Agreement.

ARTICLE VIII: OPERATING AGREEMENT

An Operating Agreement, the power to adopt, alter, amend or repeal which shall be vested in the Members of the Company, shall govern the management, operation and ownership of the Company.




