**ARTICLES OF ORGANIZATION
FOR

The undersigned, acting as the organizer of PENTA AIH, LLC under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:

**ARTICLE II
