**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is BLUEBIRD ROW BLC, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of May 12, 2017, and shall thereafter be perpetual.
