ARTICLES OF ORGANIZATION

of

VIBON GROUP LLC (A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be VIBON GROUP LLC, hereinafter referred to as the "Company".

ARTICLE II - ADDRESS
