**ARTICLES OF ORGANIZATION

Alan Manning, a natural person competent to contract and an authorized representative of a member of Blue Ribbon Bull, LLC, hereby presents these Articles of Organization as the Articles of Organization of Blue Ribbon Bull, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME
