**ARTICLE I**


**ARTICLE VII

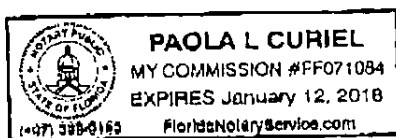
