ARTICLE IV

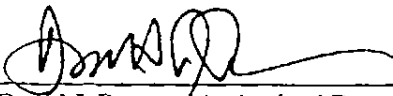
The limited liability company will be a manager-managed limited liability company, and management of the limited liability company will be vested in its manager(s).
