**ARTICLES OF ORGANIZATION  
OF

The undersigned, Aaron Stein, M.D., a natural person competent to contract and an authorized representative of TPMG PROPERTIES, LLC, hereby presents these Articles of Organization as the Articles of Organization of TPMG PROPERTIES, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is TPMG PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial mailing and street address of the Company's principal office is 1549 Airport Boulevard, Pensacola, Florida 32504. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSES AND POWERS**

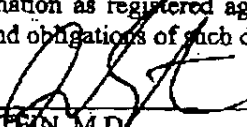
