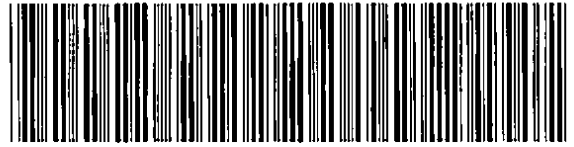




- FIRST: The name of the limited liability company is:
