The name and street address of the initial registered agent of the Company are Shelley Esden, 301 East Pine Street, Suite 730, Orlando, Florida 32801.

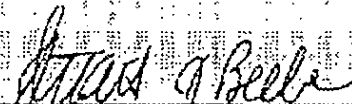
**ARTICLE V. MANAGEMENT**
