The undersigned, who is licensed or otherwise legally authorized to practice in the field of real estate sales in the State of Florida, certifies that she has associated for the purpose of becoming a professional service limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. This limited liability company shall have perpetual existence.


