**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
MORGAN SPRING HILL, LLC**

WHEREAS, the name of the company is Morgan Spring Hill, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on June 20, 2018 and assigned document number L18000151658; and

WHEREAS, the organizer of the Company has recommended the amendment to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its organizer and pursuant to the provisions of the Florida Statutes, amends the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles of Organization as follows:

1. Article IV titled Management of the Articles of Organization is hereby deleted and replaced with the following:

**ARTICLE IV
MANAGEMENT**

The Company shall be managed by the Managers of the Company as provided in the Company's Operating Agreement. The initial Managers of the Company are Alexander Clem and Sumēt Kaul, each of whom shall serve until replaced according to the provisions of the Company's Operating Agreement.

2. The date of the foregoing amendment's adoption was effective as of June 20, 2018.

3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
