4. Place of Principal Office. The mailing and street address of the Company's principal office is 4004 W. Obispo Street, Tampa, Florida 33629.

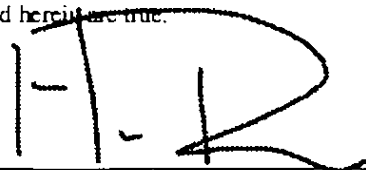

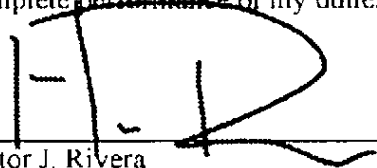
