NO SUITS**

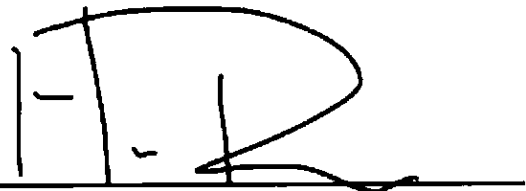
