**ARTICLES OF ORGANIZATION
OF
SOUTHERN STORAGE SERVICES, LLC**

The undersigned, Robert A. McIntosh, a natural person competent to contract and an authorized representative of Southern Storage Services, LLC, hereby presents these Articles of Organization as the Articles of Organization of Southern Storage Services, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Southern Storage Services, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

The street and mailing address of the Company's initial principal office is 3300 PGA Boulevard, Suite 350, Palm Beach Gardens, Florida 33410.

ARTICLE III – PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV – COMMENCEMENT AND TERM OF EXISTENCE

ARTICLE VI – MANAGEMENT

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:

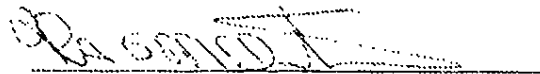

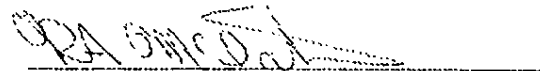
