ARTICLES OF ORGANIZATION

OF

The undersigned, being duly authorized to act as the organizer of this Limited Liability Company pursuant to Chapter 605 and Section 605.0201, Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be **Red Blue and Beyond, LLC** (hereinafter, the "Company").

Provided, however, that upon any such termination event, the existence and business of the Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Company as may be authorized by Florida Statutes.
