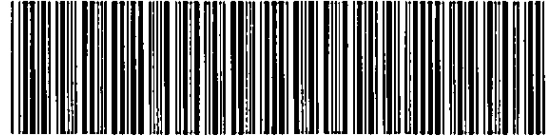

**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is GNK Properties, LLC, a Florida limited liability company (the "Company").

2. Duration and Effective Date. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

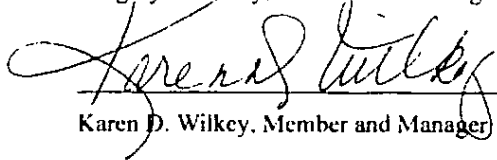
10. Certificated Interests. The members' interests in the Company may but need not be evidenced by certificates.
